# Sandtray Play Therapy: Level 6 – Expressive Arts and Play Therapy Integration (24 CEs)

## Online & In-Person Interactive

### Description

This Level 6 is being offered as a hybrid training for both in-person and online participants. The focus of this 4-day workshop is on integration of various play modalities in therapeutic settings, including sandtray play, puppets, games, art, and storytelling play. Through didactic and experiential methods, therapists will have opportunities to learn how and when to use various modalities with both child and adult play. There is special emphasis on integrating the sandtray with play therapy and verbal therapy. In addition, participants will have opportunities to practice nervous system attunement during play therapy exercises.

Participants at the site in Corrales, New Mexico will be using various sizes of trays and a large collection of miniatures provided at the site. Online participants will provide their own individual tray(s) and miniature collections at their local sites. Online participants will be able to view demonstrations taking place at the Corrales site. Interaction between online and in-person trainees will be possible, encouraged, and formalized through breakout rooms and large group discussions. Participants at the Corrales site will be able to interact with online participants through a large screen and sound system. Breakout rooms are facilitated between in-person and online participants through smaller computers and headsets.

**Prerequisites:** Levels 1 & 2; graduate degree in mental health or enrolled in a graduate degree program.

**Backup Plan in Case of Internet Outage:** In the event of internet connectivity problems at the host site, the morning following the last day of the training will be used to fulfill any lost contact hours for online participants. ## Educational Goals

This training will help participants to:

1. Identify facilitation skills for integrating sand tray play with other play therapy modalities.
2. Utilize puppet play to enhance play therapy.
3. Describe mosaic play as it relates to sandtray play therapy.
4. Utilize sand tray miniatures to create a genogram.
5. Explain how the use of clay (or masks) reinforces the image thinking that is also a core idea in sandtray play therapy.
6. Describe play therapy benefits of using parallel play such as coloring and doodling.
7. Explain how games may or may not enhance sandtray play therapy.
8. Discuss directive versus nondirective methods for utilizing collage making in play therapy.
9. Discuss how the polyvagal theory provides a science-informed perspective on using a variety of play therapy methods in conjunction with sandtray play therapy.
10. Identify the role of Panksepp’s innate primary motivational circuits in sandtray play therapy.

### Checking Your Personal CE Requirements

It is always a good idea to check with your own credentialing agencies (state boards, affiliated agencies, etc.) to ensure that the CE credits you receive from us are applicable to your specific situation. ### Cancellation and Refund Policy

Registration fees are refundable (less \$50.00 administrative fee & any credit card fees) if written notice is post-marked no later than 30 days before the training begins. Refunds require a minimum 6-week processing time. Registrants may transfer/sell their enrollment to another qualified person at any time. Transfer fee is \$50.00.

The Sand Tray Training Institute reserves the right to cancel a workshop due to insufficient enrollment, inclement weather, instructor illness, instructor family emergency, or some other unforeseen event. Notice will be provided at the earliest possible date via email with the option to reschedule for a future training date or to receive a full refund of paid workshop fees.

### Materials for Online Participants

This workshop involves a lot of hands-on activities and supplies. Our training facility will send some of the supplies to you charging only shipping & handling of \$40 (cost subject to change according to US Postal Service rates) if you register 30 days prior to the beginning of the workshop and if your mailing address is within the continental United States. If you register after that date, we will still send the supplies, but they may not reach you by the beginning of the workshop. For participants outside the United States, we will supply all the materials, but you will need to cover the extra costs of shipping internationally if you are outside the United States. Alternatively, we will provide a list of the materials you need if you want to assemble your own supplies. We can send a partial box of supplies, but the postage and handling cost is the same.

### Makeup Policy

Certificates can be awarded only when the training is attended in full. In case of medical or family issues, makeup work may be arranged on an individual basis at an hourly consultation rate.
